## MEMORANDUM OF SOCIETY

1. NAME OF THE SOCIETY:

The name of the society shall be: "INDIAN REPROGRAPHIC RIGHTS ORGANISATION."

2. REGD. OFFICE:

The Registered office of the society shall remain in the National Capital Territory of Delhi, and at present it is at the following address:

18/1C, Institutional Area, New Delhi-110067.

3. AIMS AND OBJECTS:

Aims and objects of the society, for which the same is established, are as under:

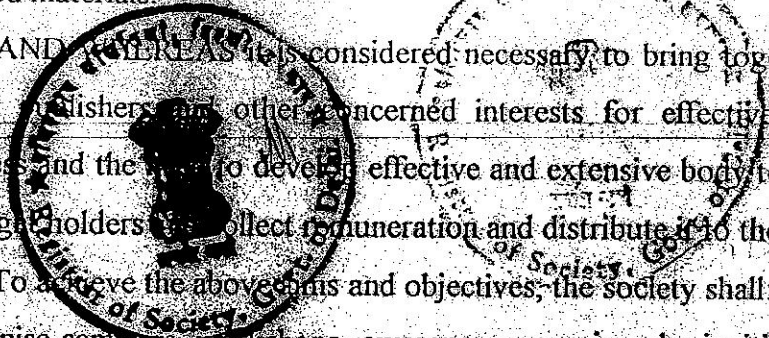
WHEREAS there is rapid growth and large scale photocopy access to works and of productions of copyright protected materials.

AND WHEREAS it is essential to establish a collective administration of reprographic reproduction rights on a voluntary basis to maintain the sanctity of copyright protected materials.

AND WHEREAS it is considered necessary to bring together various institutions, authors, publishers and other concerned interests for effective development of public awareness and the need to develop an effective and extensive body to issue licences on behalf of the right holders, to collect remuneration and distribute it to the right holders.

To achieve the above aims and objectives, the society shall:

- (1) organise seminars, workshops, awareness campaigns by inviting experts, distinguished luminaries, academicians, authors and editors for discussions, lectures or such other activities by which the aims and objects of the society can be furthered.
- (2) Promote and spread awareness in regard to collective administration of reprographic reproduction rights on voluntary basis.
- (3) Develop integrated collective administration organisation to issue licences on behalf of the right holders, collecting remuneration and distribute it to the right holders.
- (4) Provide assistance, participate and encourage any joint attempt by the authors and publishers to establish national collecting societies in the field of reprography.

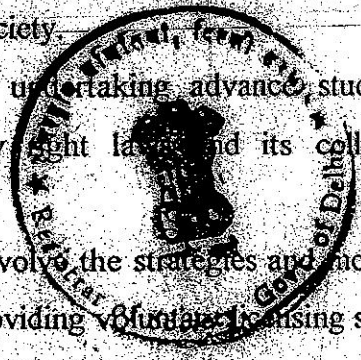
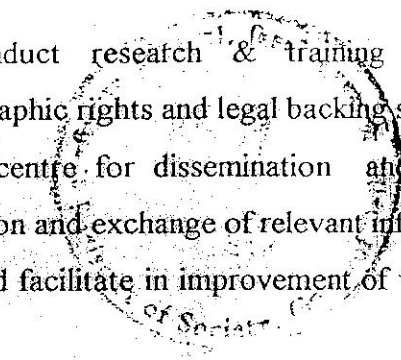

- (5) Promote, spread, help, support and raise its concern for the cause and disseminate the views of its members at various international copyright forums.
- (6) Develop, raise, organise formal agreements and information relationship among and on behalf of its members.
- (7) Document all relevant information pertaining to reprographic licensing system and its issues.
- (8) Advise and if needed, assist the Government in the formation and implementation of policies and reproduction rights.
- (9) Organise, promote education, conduct research & training and professional development on production of reprographic rights and legal backing systems.
- (10) Promote and establish a resource centre for dissemination and diffusion of the knowledge of reprographic reproduction and exchange of relevant information.
- (11) Continue to monitor as a catalyst and facilitate in improvement of voluntary licensing systems.
- (12) Offer awards, prizes, scholarships and stipends for the furtherance of the objectives of the Indian Reprographic Rights Society.
- (13) Cooperate and collaborate with other national or international institutions for the furtherance of the objectives of the Society.
- (14) Promote and establish centres for undertaking advance studies and research in reprographic reproduction and copyright law and its collective administration according to the needs of its people.
- (15) Initiate, encourage, participate and evolve the strategies and models in upholding the individual right of reproduction by providing voluntary licensing systems and collective administration to collect and distribute this remuneration.
- (16) Constitute, establish or cause to be constituted regional offices at convenient centres in India to promote the administration of the RRO for the benefit of the public and authors as well as publishers at large.
- (17) To protect the rights of its members by initiating appropriate proceedings as may be deemed fit.

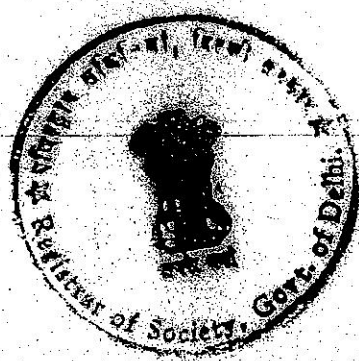
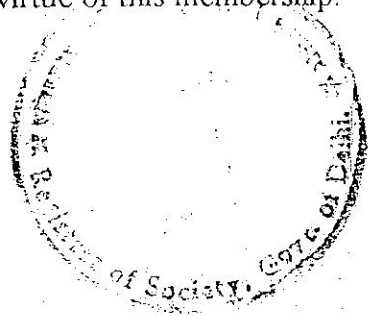

(18) To do all such other acts and things as are incidental or conducive to the attainment of any or all of the above objectives.

(19) All the incomes, earnings, moveable/or immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of the society and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members of the society or to any person claiming through any one or more of the present or the past members. No member of the society shall have any personal claim on any moveable or immovable properties of the society or make any profits, whatsoever, by virtue of this membership.



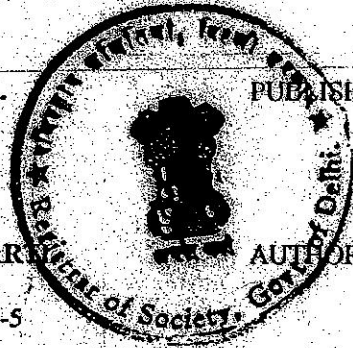

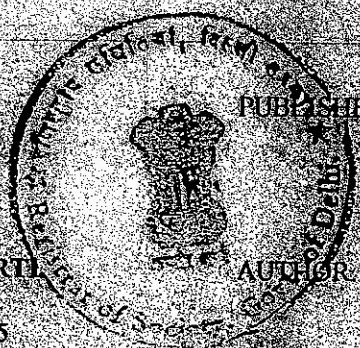
