IRRO Licensing Tariff Structure

1. For Educational Institutions

A) No differentiation between Govt. / Private / Charitable

(1) For less than 250 Students

- License fee Rs. 5000/- + GST per year.

(2) For 251 to 500 students

- License fee Rs. 9000/- + GST per year.

(3) For 501 to 1000 students

- License Fee Rs. 15000/- + GST per year.

(4) For > 1000 students

- License Fee Rs. 20000/- + GST per year.

(5) Professional Courses: Engineering, Management, Medical, IITs, Libraries etc.

- License Fee Rs. 24000/- per annum + GST per year.

B) Photocopy limit is not more than 15% of the Work or one chapter, whichever is greater.

C) Logs of copyrighted published Works being photocopied to be maintained in a specified manner (ISBN, Publisher, Author, Title, Number of pages etc.)

2. For Commercial Photocopying shops

a) For photocopying machines capacity more than 1000 pages per day
- Minimum license fee 10,000/- per year, Photocopy allowed: 50,000 pages per year of copyrighted published Work. If number of photocopied pages increase, the license fee shall increase accordingly.

b) For photocopying machines capacity less than 1000 pages per day
- Minimum license fee 7,000/- per year, Photocopy allowed: 50,000 pages per year of copyrighted published Work. If number of photocopied pages increase, the license fee shall increase accordingly.

c) Logs of copyrighted published Works being photocopied to be maintained in a specified manner (ISBN, Publisher, Author, Title, Number of pages etc.), number of pages etc.

Photocopy limit is not more than 15% of the Work or one chapter, whichever is greater.

3. Other than educational institutions;


- a) On the basis of number of employees or people working: 50/- per person per annum or subject to a minimum amount of 2000/- + GST per location per annum.

4. Transactional License: For one time or infrequent copying against advance permission of licensing: Per page basis plus minimum charges. Licensee to provide details of the works to be copied. Rates to be quoted on case to case basis.

5. Other Organisations: License fees to be quoted on request.

TERMS & AND CONDITIONS:

- 1) Licence fee must be paid on annual basis i.e. the license will come into effect from the date of commencement for a period of one year and then continue from year to year, subject to renewal of license. Late payment will attract a penalty of 10% every quarter or part thereof.
- 2) All payments are to be made only by way of demand draft, pay order, or NEFT in favor of "Indian Reprographic Rights Organisation" only.
- 3) License fee above are applicable strictly for one campus only. For each campus license fee calculation as well as license fee payments shall be made individually and separately. This shall be irrespective of parent establishment or affiliation or its head office having paid for itself.
- 4) All License Fee calculated on per employee basis shall always include employees on contract, employees through service provider and / or employees working at /for the offices of the said establishment. Exemption shall be provided only in cases where the services provider/contractor produces written or electronic proof showing that License Fee has already been paid for employees working through his payroll.
- 5) Receipt of IRRO tariff scheme constitutes "Notice" under law. Failure to procure valid license(s) shall be prosecutable under various civil and criminal laws and procedures.
